1. Welcome and Work to Date Update

Karla Boughton, Poulsbo Planning and Economic Development Director welcomed members and thanked them for their continued attendance and involvement. Peter Batuello, PERC Project Manager updated the Committee on work to date on the community open house and live zoom chats held in March 2021, the progress of the Market Analysis study, evaluating site options, and the City's partner in this feasibility study, the Kitsap Public Facilities District and their obligation for economic uplift and sales tax revenue generation.

2. Hopes and Dreams – ARC Architects Presentation

Peter Batuello introduced ARC Architects who were selected through a competitive process. Peter introduced Paul Curtis, Emily Wheeler and Ariel Jameson from ARC Architects, and Michael Faulkner from BD Associates (landscape architect). ARC consultants made a powerpoint presentation: introducing the firm, overview of schedule of their component of the feasibility study, discussed balancing of program needs (uses) and program means (costs), gave a preview of site opportunities, and concluded with next steps. Committee members asked questions and provided comments verbally and in chat box throughout the presentation. See comment summary.

3. Final Discussion and Next Steps

After ARC presentation and discussion, Peter Battuello asked if there was anything missing or to add that hadn't been already discussed. Discussion on funding and the site size limits how much can be accommodated. The meeting closed announcing the next Steering Committee with ARC is scheduled for Thursday, July 15th beginning at 5:15 p.m.

PERC STEERING COMMITTEE MEETING #2
COMMENTS SUMMARY
June 10, 2021 - 5:15-7:00pm

The City of Poulsbo convened the PERC Steering Committee on June 17, 2021, for the Committee's second meeting on the PERC Feasibility Study. ARC Architects presented a PowerPoint and discussed each slide. {See PowerPoint presentation.} Committee members asked questions and provided comments throughout the meeting verbally and in the chat box. PowerPoint key points and comments are as follows:

- ARC presented the overall approach to the project and schedule, and the purpose and outcome of today's Steering Committee meeting. The meeting is big picture and hopes and dreams, building on the community survey and open house comments.
- Consideration of programming of uses started with community survey and the uses BERK consulting are using for the market study. ARC has added additional uses for consideration based on their experience.
- ARC presented slides on 1) Indoor Spaces – Event Spaces/Rooms, Fitness Area/Classes/Courts, Gymnasium, and Aquatics; and 2) Outdoor Spaces – Fields, Walking/Running trails, Amphitheater, Plaza, Ancillary Courts, Playground, Water Feature, Picnic Area.
- Question from SC Member: Has there been a gap analysis completed and does that identify what is or is not already available in the community?
 - Response: BERK Consulting's Demand Analysis does tackle a bit of a gap analysis, identifying similar uses and facilities in Kitsap that provide the uses contemplated for the PERC.
- Question from SC Member: Has spectator seating been designed into the layout?
 - Response: ARC responded that they are not near the point of designing spectator seating but looking for ideas from the group on how much seating antidotally would be a good number.
- Discussion on event space attendance, 200-300 persons. Chat comments on events in the community that could use the PERC, such as the Chamber of Commerce Annual Gala.
- Chat discussion on flexibility and multi-use spaces. Find the 'niche' or 'feel' that cannot be achieved at the other event spaces.
- Portable stage and collapsible seating should be considered as a flexible way to provide performing arts without designing a performing arts facility.

- Discussion on use a gymnasium: how courts and cross courts are set up, and potential use as meeting space, and concerns about that.
- Discussion: ensure all elements that are necessary if we want to use the space for tournaments are included, otherwise they are expensive to added afterward.
- Discussion: by adding height to the gymnasium for volleyball, an indoor track becomes feasible. Is an indoor track important? Yes, it is important, and the community survey also supports a desire for indoor walking.
- Comment from SC Member: the fitness and classrooms are the most needed as the current recreation center is in dire need. Need to take into account the City's parks and recreation programming offered pre-COVID and see what was offered. The community will be upset if these programs are not part of future programming.
- Discussion: Class and smaller scale activities, types of classes and how they can be multi-use – for example for younger ages during the day and for teens in the evenings.
- Question from SC Member: Will preschool be offered at the PERC?
 - Response: The City ceased the preschool program last year due to COVID, and the City is considering whether to restart the program.
- Question from SC Member: How are the rooms being used?
 - Response: Programming of the rooms and renting of the rooms will be managed by the City's Parks and Recreation programmers.
- Discussion: Fitness room and equipment, is this important element of the PERC? This could support the students at the adjacent OC/WWU.
- Discussion: Another element that could both support students and the community is a Makers space. There was sense from the colleges that a Makers space would be used by students.
- Discussion: What are the desired elements of an aquatic facility? Cool water for lap swimming, or warmer water for a community/family pool? There is the NKSD pool and pool at Bangor Naval Base, as well as other nearby pools. There has been interest in splash pad as well.
- Concerns: About cost estimates of an aquatic facility and long-term operating and maintenance costs. The community has spent a lot of time and money to keep the NKSD pool open.
- Concerns: Two pools (one cool water, one warm water) double the amount of water to heat, dehumidify and purchase. Pools usually operate at a loss, and should be considered versus a community center, which can get close to breaking even.

- Question from ARC: Is there interest in an outdoor pool? They get closer to breaking even because the cost of heating and cooling a building is a big part of the expense.
- Discussion on Outdoor Activities: multiple sports can be played on same field – soccer, football, lacrosse, rugby, ultimate frisbee, possible to overlay softball and baseball. Basketball, tennis and pickleball can be combined. What about playgrounds, plaza, water feature? Multi use outdoor space for public gatherings such as concerts, guest speakers, ceremonies, Shakespeare in the Park, public art
- Discussion: It seems like we are considering everything to go on the PERC site. There are other City parks where some of these elements can be sited?
 - Response: Yes, there are City parks where some of the elements can be improved at. The PERC is an addition, not a replacement. It will be key to prioritize the outdoor activities.
- Discussion on other outdoor activities: walking trails connecting to other areas at College MarketPlace,; concessions or food trucks for event days?; water feature as part of plaza; outdoor concerts and plays; outdoor movie screen.
- Adjacency considerations: a multiuse room for events could be designed to open up to the amphitheater or open outside area and double the event space.
- ARC discussed generally how costs estimates are calculated and translated into a \$ amount per square footage.
- ARC discussed the site features of the PERC parcel. They showed a slide of with elements to scale, like fields, building, courts, parking, plaza, amphitheater and seats, access to site, and others.
- Concerns: ensuring adequate parking for the day-to-day activities and the events that may generate more parking demand. Cannot underestimate the parking demand.
- Funding consideration: Look for corporate sponsorship and family sponsorship; buy a room or buy an outdoor movie screen.
- Discussion: There may not be enough room for two tournament size soccer fields and there will be a decision to make that the site does not fit everything wanted. ARC will come back in July with options to begin the discussion of priorities.

- Next Steps: ARC will take comments and begin to define the program in terms of area of the site and in terms of costs. Two parts of the puzzle; the inside programming and how the outside elements fit on the site.

- Final comments/questions:
 - There is a lot of desires and a finite parcel of land. It cannot be all things to all people.

 - How is this going to be funded? Who is going to be asked to fund it? The Financial Analysis is a component of the Feasibility Study and that will be addressed there. Voted bonds or a park district are likely necessary to fund and maintain the PERC. There is limited, potentially competing geographies for the formation of a park district.

 - Next Steering Committee Meeting with ARC is Thursday, July 15th beginning at 5:15 p.m.
